

- 1. Using the **Lightning App Launcher** *iii*, navigate to **Contract Lifecycle Management (CLM)**.
- 2. In the **Lightning Navigation bar**, click **Vlocity Document Clauses**. We've added several clauses already.
- 3. At the top of the page, click **New**.




## Task 4: Set template section display conditions

- 1. Open the **Payment Terms** section, scroll to view below the clause content, then click **Use Advanced Entity Filters**.
- 2. Rename the entity filter to Contract Account Is In USA, then click Create Filter.



- 3. Click Add.
- 4. Keep Field selected as the type.
- 5. Click Select in the Field/Attribute/Related Object field:
  - a. Select Contract<vlocity\_cmt\_\_ContractId\_\_c>.
  - b. In the second pane, select Account ID<AccountId>.
  - c. In the third pane, select Billing Country<BillingCountry>.
