Legal residents of Brunei, Cambodia, Indonesia, Laos, Malaysia, Myanmar, the Philippines, Singapore, Thailand, and Vietnam who are 18+ of age may participate in this program.

Salesforce certification vouchers worth US\$200 are available to all who complete the webinars and the three Trailmixes by October 17th, 2021. Limit one (1) voucher per individual. Vouchers are limited to those 18+ of age and are the legal residents of Brunei, Cambodia, Indonesia, Laos, Malaysia, Myanmar, the Philippines, Singapore, Thailand, or Vietnam.

Salesforce certification vouchers worth US\$400 are available to all who participate in the Demo Day event part of this program. Limit one (1) voucher per individual. Vouchers are limited to those 18+ of age and are the legal residents of Brunei, Cambodia, Indonesia, Laos, Malaysia, Myanmar, the Philippines, Singapore, Thailand, or Vietnam. Participation in Demo Day is based on the submission of an app that meets minimum technical specifications.
